SNAP Online Food Purchasing Now Available in Ohio

Ohioans using the Supplemental Nutrition Assistance Program (SNAP) can now order pick up from Walmart or delivery from Amazon. While Ohio SNAP recipients can order food online from a variety of retailers, only Walmart and Amazon allow online purchasing with EBT cards. Individuals may choose to have groceries delivered, but federal rules still prohibit using SNAP benefits to pay for any delivery charges. Both Amazon and Walmart have more information regarding these programs on their websites.

Individuals may qualify for SNAP if their household's gross monthly income is at or under 130% of the federal poverty guidelines. Ohioans can apply at benefits.ohio.gov. Benefits can be used to buy most food products, with the exception of alcoholic beverages, vitamins and/or medicines, and hot food made to be eaten immediately, including prepared food from grocery stores and restaurants.

Although many people have already received their stimulus payment, some are still unsure if they qualify. They may struggle with using the website, or not have internet access. They may need to provide more information to the IRS to receive their payment.

The Ashtabula Farmers' Market

The Ashtabula Farmers' Market will be opening for the season on Sunday, June 14th from 10:00 a.m. to 2:00 p.m. They will be in their usual location on Bridge Street next to the Marine Bank Building.

Due to COVID-19 they are doing things a bit differently this year. Shopping from 10:00 a.m. to 10:30 a.m. will be for seniors and vulnerable people only. The Farmers' Market is taking the usual precautions of asking anyone who feels ill to stay home, even if it is only a mild illness. Customers are asked to wear masks, though they are not requiring them to be worn. Customers are not to congregate in groups of ten or more. Customers are asked to stay six-feet apart from vendors and other customers.

Additionally, the Farmers' Market is asking customers to refrain from touching product. Product will be bagged in a new plastic bag. Reusable bags will not be used.


