# **Dear Customer,**

In the next few weeks, we will be installing smart meters on homes and businesses in your area. This effort is part of a three year investment approved by the Public Utilities Commission of Ohio to modernize our electric distribution system in Ohio with advanced automation equipment, real-time voltage controls and the installation of 700,000 smart meters.

This step toward a more modernized electric system will enable automated meter readings and may enhance our ability to respond to outages faster and more efficiently.

Plus, in the future, you will have access to more detailed energy information through our online Home Energy Analyzer tool that will help you better understand your electricity use – which means you can then make informed decisions on how to manage and control your electricity consumption.

**Exchanging your current meter with a smart meter takes very little time and even less effort from you.** In fact, if your meter is readily accessible, you may not even need to be there when it occurs. On the day of the installation, an installer from FirstEnergy or our vendor—Wellington Energy—will come to your door, while maintaining proper social distancing, to let you know they are installing your meter. If no one answers, we will leave a door hanger either indicating that the meter has been changed or asking you to contact us to schedule an appointment to change your meter.

The installer will not enter your residence. Please be aware that all of our installers will be following proper safety measures and taking necessary precautions recommended by the Centers for Disease Control and Prevention against the spread of COVID-19. In addition, they will be carrying a photo identification badge from FirstEnergy. FirstEnergy installers will also have FirstEnergy uniforms and trucks. Wellington Energy installers will wear a brown uniform with a Wellington logo and their white trucks will have Wellington Energy and FirstEnergy logos. If an installer cannot show you an identification badge, or if you have a concern about that person's identity, please call Wellington Energy at 888-895-1044

The installation may have required a brief interruption in your service. As a result, you may need to reset some of your electric equipment.

Be assured that the smart meter technology being implemented has been rigorously tested and proven by manufacturers to be accurate, safe and secure in systems throughout the country. Making homes more comfortable, affordable and addressing health and safety concerns, the Home Weatherization Assistance Program (HWAP) provides eligible Ohioans with assistance to improve the energy efficiency of their homes and reduce energy costs. Eligible participants receive a home energy inspection to determine the most cost-effective energy efficiency improvements for the home. Based on the results of the inspection, a plan to improve the home's energy efficiency is determined. The plan may include insulation of attics, sidewalls and floors, air reduction , tuneup/repair or installation of a hot water tank and/or heating unit.

# **The Winter Crisis Program Continues**



The Winter Crisis Program is a utility assistance program provided through Ashtabula County Community Action Agency. The program can provide income eligible households with

once per heating season assistance with their main heating source.

The program began November 2nd and ends March 31st, 2021.

Due to Covid-19 things will be different this year from previous years. The first big change is that there won't be any walk-ins or in-person appointments. Instead all appointments will be over the phone. All applicants will need to have all of their required documentation in before their appointment time. They can do this in three ways.

- 1. They can fax all of their information to 440-997-6022.
- 2. They can email their information.
- They can get copies made/ drop off copies at 6920 Austinburg Rd, Ashtabula.

The documents needed are much the same as previous years. They will need:

- A photo ID
- Proof of Income for the last 30 days (or 12 months if self employed or seasonally employed)
- Social security cards for all household members
- All pages of their current utility bill
- If renting they will also need the landlord's name, address, phone and rent amount

After they have collected and turned in all of their documentation they can call the appointment line at 440-381-8230 to set up their over-the-phone appointment.

To be eligible for the Winter Crisis Program the client must be an Ashtabula County resident and the household income must be at or below 175% of the Federal Poverty Guidelines. The account must be in the name of an adult household member. They must also meet at least one additional eligibility criteria: the account must be in disconnect status, have been shut off, need new service, need transfer of service, or have 25% (or less) bulk fuel supply remaining OR they have a household member that was diagnosed with Covid-19 in 2020.

# Ashtabula County COVID-19 Guidelines

Ashtabula County is still red. Continue to follow the guidelines as instructed in Level 1 and Level 2:

- Conduct a daily health/symptom self-evaluation and stay at home if symptomatic.
- Maintain social distancing of at least 6 feet from non-household members.
- Wear face coverings in public.
- Increase caution when interacting with others not practicing social distancing or wearing face covers.
- Avoid traveling to high-risk areas.
- Wash hands frequently with soap and water for at least 20 seconds.
- Use hand sanitizer frequently.
- Avoid touching your face.
- Cover coughs or sneezes (e.g., into a tissue, or elbow).
- Avoid contact with anyone who is considered high-risk. And high-risk individuals should take extra care to follow precautions.
- Decrease in-person interactions outside household.
- Seek medical care as needed, but avoid unnecessary visits to hospitals, nursing homes, and residential care facilities to see others as much as possible.
- Additional Guidelines for red, or Level 3:
- Decrease in-person interactions with others.
- Consider necessary travel only.
- Limit attending gatherings of any number.

# **COVID-19 Vaccine Update**

Local Health Departments and healthcare centers have begun registration for the COVID-19 vaccine. According to the governors office, starting on the week of January 18th, Vaccine providers will begin receiving their first allotment of vaccines for those ages 80 and older. Every week after they will expand the age limit by five years. The week of January 25th vaccinations will be expanded to 75 and up, then the week of February 1st they will include those 70 and up, then on the week of February 8th they will expand to those 65 and up.

Individuals with severe congenital, developmental, or early-onset medical disorders, will be able to start getting vaccinated on the 25th of January. K-12 school employees can get the vaccine starting on the 1st of February.
